Members of the Building Industry Employers Assn. through participation in one of following organizations and who employ a monthly average of 50 or less employees, qualify for participation in this group

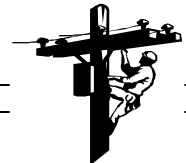

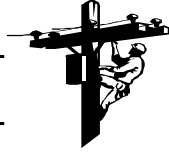
